

These problems were created by the passing of the one-sided parking ordinance. The reason that Larry Coulson is mentioned is because these same residents spoke with him concerning their complaints as our Alderman. Larry said that they needed to go to the HOA, even though the HOA has been told repeatedly that they have no jurisdiction where the streets are concerned and that City would do whatever they wanted. You will also see that I did not ask for, nor suggest that the parking be moved to the other side of the street. I did not receive anything back from the Mayor nor did she return any of the phone messages that I left for her at City Hall.

Can we please set a time to meet to discuss a parking issue that has come up since the ordinance in Hunter's Glen has been changed to one-side street parking.




Mayor Haas,

With that being said, I then sent an email to William Brooks on March 27 which is also provided for your reading. William spoke to me specifically after our meeting down at City Hall when the parking proposal was on the table and told me if ever had any concerns, to please let him know. As you can see from the email, I expressed my concern over the Mayor never responding to my emails or phone calls, and then the same issues that I expressed in the email to the Mayor. In his email, I specifically ask for there to no parking on the curve on Eagle Crest on either side of the street because it poses such a hazard. Nowhere in any communication will you see that asked for signs to get moved. Although we pointed this out as a problem before the ordinance was passed, the City didn't listen. But I don't think that changing it now is going to fix the problem on the Eagle Crest curve which my only concern. His response was to give him a call which I did. He said that he and Adam, the code enforcement officer would come and evaluate the situation and Adam would then make contact with me.



William,

I have now sent Mayor Haas three emails, two of them in the last two weeks. She has not responded to anything I have sent.

We now have a parking issue at the bottom of Eagle Crest because people are parking on both sides of the street on the curve; blocking the fire hydrants; blocking the drive to the water treatment plant; and blocking driveways and preventing people from backing out of their driveways safely or backing out at all. Even when they do park on the designated side it is in front of the fire hydrant and also prevents people from seeing oncoming traffic around the curve. These are issues that were created by the parking ordinance and were issues that we warned were going to happen.

At the last meeting that you attended for our HOA to discuss the tax increase, you made the statement that the only reason that you voted for this parking ordinance was because of a safety issue and I am sorry, but we didn't have a safety issue before this ordinance and the plan the City designed has parking on the side of fire hydrants on 3 of our 5 streets (the main streets). How can this be safe?

Regardless, I am trying to get some help to just put no parking on the curve on Eagle Crest at any time to alleviate the safety issues we are now facing and I can't even get a response from the Mayor. Please help!!

At our HOA meeting held on March 11 to discuss the City taking over our storm sewer system, William was the only alderman that attended the meeting. The only discussion we had concerning the parking complaints was that William stated that they were working on it.

On April 7, I sent William a text message stating that I had not heard from Adam. He said that Adam made contact with Stephanie, our HOA president. When I questioned why he said that Adam got in touch with her first and I explained that I was disappointed because I was trying to take care of the

complaints so that Steph didn't have to and that she really wasn't aware of previous communication. I also explained, as I have on numerous occasions that we do not have a HOA President and gave names of the three trustees again.

My next text message from William came on May 3 stating that they would be voting on the parking that night.

The next message came on May 6 stating that it passed to move parking to the opposite side of the fire hydrants and the trustees were supposed inform the residents that the signs would be moved. This was the same day as that Larry made the FB post asking for everyone's input and so I then ask William if it was still being discussed or it was done? He said it is done and there will be any voting on May 17.

First of all, my intent was to simply pass on the problems to the City who continues to make us aware that they have the power over our streets. I have often referred residents to the Police Department and from now on that will be my response to anyone having issues. Secondly, I never wanted one-sided parking, but as a trustee we ask for the input of residents and we represented the majority to the City. It is simple.... our voices were not heard or listened to but my heart doesn't break for me, it breaks for those directly affected by it. You see, the parking isn't on my side of the street and I park in my garage and driveway. I have always been fighting this fight for you all to have a voice. Thirdly, the behavior of neighbors on FB is not only hurtful, it is embarrassing and therefore, I will not participate in anything posted there again. I have learned my lesson and moving forward, the only way to send anything to the trustees is through the email and our communication to you will be through the webpage, email, and newsletters. Lastly, I ask that you understand that your trustees will never be able to make everyone happy, but we are listening and trying our best.
